Suwannee River, Santa Fe River, Hart Springs, Otter Springs, Several boat ramps, Gulf Coast and Cave Diving Excursions

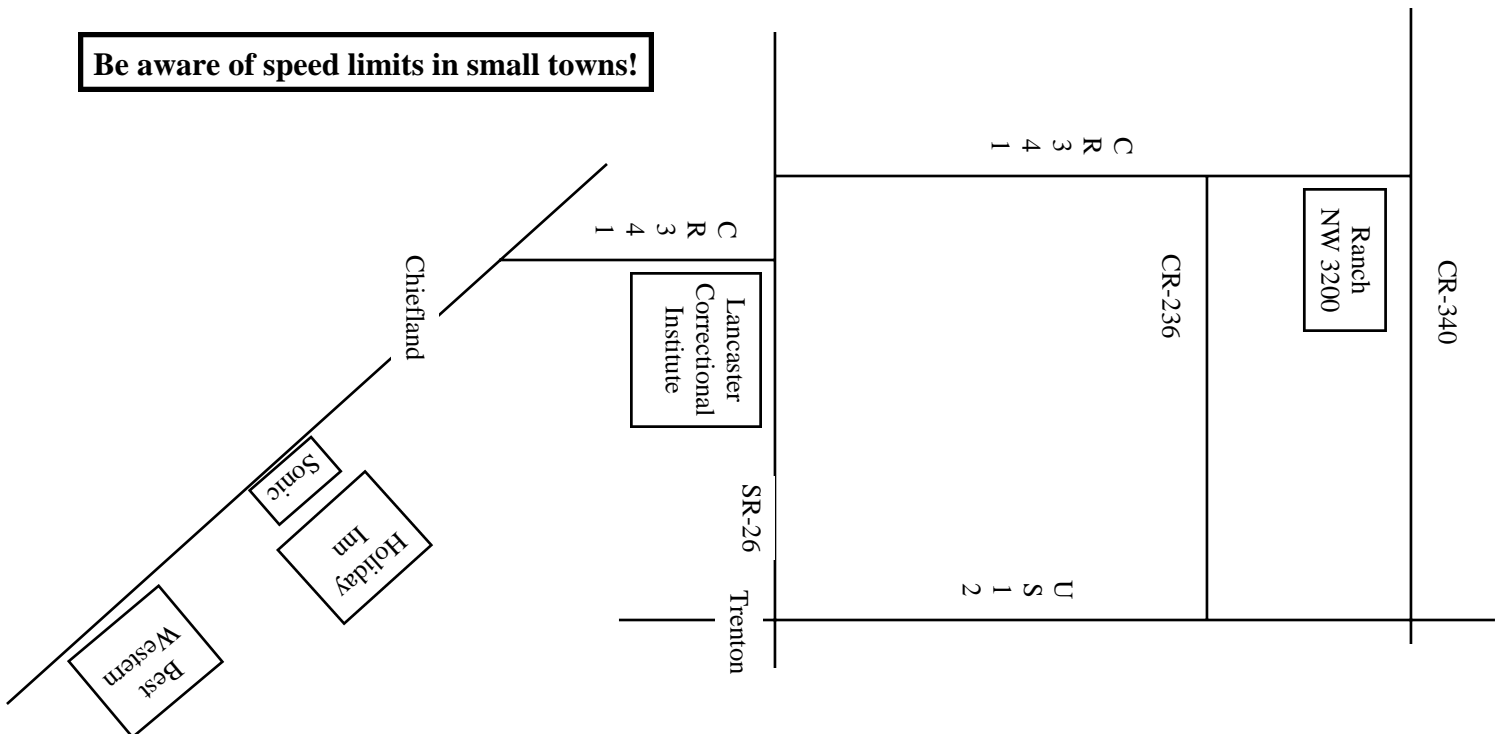
Directions

To Best Western & Holiday Inn from south: Florida Turnpike north until it ends. I-75 north to Gainesville/Newberry exit. Go west on Newberry Rd. (US-26) go through Trenton. When you see Lancaster Correctional Institute on left, turn left at next street CR 341 go south to Hwy 19, turn left continue south on Hwy 19, Holiday Inn behind Sonic on left. Best Western a little further down on left.

To Best Western & Holiday Inn from north: I-75 south to Gainesville/Newberry exit. Go west on Newberry Rd. (US-26), then follow directions above.

To Ranch from south: Florida Turnpike north until it ends. I-75 north to Gainesville/Newberry exit. Go west on Newberry Rd. (US-26) go through Trenton. From Lancaster Correctional Institute, continue west on US-26. CR-341 (BP Gas Station on left) turn right go north (approx. 11.8 miles) ranch will be on the right (3200 NW CR 341 Bell, Fl).

To Ranch from north: I-75 south to US-222 west to CR-241, turn right, go north to CR-232, left turn, go west US-129, right turn, go north thru Town of Bell. At CR-236, turn left (Gilchrist Building Supply on right) go west to CR-341, turn right, go north (approx. 1.1 mile ranch on right).
